GENERAL GOVERNMENT MONTHLY FINANCIAL STATEMENT FOR THE FOUR MONTHS ENDED 31 OCTOBER 1999

Accrual Result

The General Government operating result for the four months ended 31 October 1999 was a surplus of \$781 million.

General Government net worth at 31 October was \$37,999 million.

GFS Result

The General Government GFS result for the four months ended 31 October 1999 was an underlying surplus of \$251 million. The result comprises a surplus of \$1,049 million on current transactions and a deficit of \$798 million on capital transactions.

Total receipts amounted to \$8,533 million and total underlying outlays amounted to \$8,282 million.

The 1999/2000 Budget projects full year receipts of \$25,987 million and total underlying outlays of \$25,773 million.

After the first four months of 1999/2000, the Budget remains on track for an underlying surplus of around \$200 million
