#### About the GSF Agency List Guide

- GSF agencies are defined in the GSF Act.
- This list serves as an indicative guide to the entities which are GSF agencies under the GSF Act.
- Agencies should have regard to the definitions of 'GSF agency' used in the GSF Act and obtain appropriate legal advice when in doubt.
- Treasury, with input from agencies, have made every effort to ensure the accuracy of the information provided however, your support in maintaining this accuracy is appreciated.
- You can notify Treasury of any changes to the list via [Notification of a GSF agency status](#)
  - under the GSF Act, an Accountable Authority has an obligation to notify the Treasurer and the Auditor-General of any new GSF agencies within one month after the entity becomes a GSF agency (refer s 2.8(1) of the GSF Act)
  - if agency has been abolished/dissolved (such as dormant entities; noting that dormant entities remain listed until formally dissolved)
  - provide any other updates (e.g. change of name, classification, accountable authority or status) in relation to GSF agencies in the list
  - note any movement of entities between the portfolios; if there are substantial Machinery of Government changes Treasury will undertake a separate collection update across all portfolios
