GENERAL GOVERNMENT MONTHLY FINANCIAL STATEMENT FOR THE FIVE MONTHS ENDED 30 NOVEMBER 1999

Accrual Result

The General Government operating result for the five months ended 30 November 1999 was a surplus of \$1,109 million.

General Government net worth at 30 November was \$38,336 million.

GFS Result

The General Government GFS result for the five months ended 30 November 1999 was an underlying surplus of \$526 million. The result comprises a surplus of \$1,494 million on current transactions and a deficit of \$968 million on capital transactions.

Total receipts amounted to \$10,686 million and total underlying outlays amounted to \$10,160 million.

The 1999/2000 Budget projects full year receipts of \$25,987 million and total underlying outlays of \$25,773 million.
